



THURSDAYS AND SUNDAYS IN APRIL

1. Barona's \$750,000 VIP Lucky Chance Free Play Giveaway takes place March 30 – April 30, 2026, and is open to Diamond, Sapphire, Platinum, and Gold players only.
2. \$50,000 weekly drawings take place at 10pm every Thursday and Sunday night (excluding Thursday, April 30).
3. Entries for the Thursday night drawings will be earned 12:15am Monday – 9:30pm Thursday on the same week of the drawing. Entries reset each week.
4. Entries for the Sunday night drawings will be earned 12:15am Monday – 9:30pm Sunday on the same week of the drawing. Entries reset each week.
5. The Grand Finale drawing will take place at 10pm on Thursday, April 30, 2026.
6. Entries for the Grand Finale drawing are accumulated continually 12:15am Monday, March 30 – 9:30pm Thursday, April 30, 2026.
7. Entries can be earned while playing with a qualifying Club Barona Card on slots, keno, video poker, and table games.
8. Players can earn an unlimited number of entries; Weekly drawing entries are earned at a rate of one entry per every 500 slot tier points (or equivalent table games play). Grand Finale drawing entries are earned at a rate of one entry per every 500 slot tier points (or equivalent table games play).

Players can be drawn to win multiple times per week (i.e., be drawn on Thursday and Sunday), but are limited to one prize per drawing day and one \$10,000 free play prize per week, but may win in following weeks. To qualify for the \$25,000 prize, a player must be a Diamond, Sapphire, or Platinum-level Club Barona member, and have earned at least one entry into the Grand Finale drawing. 12. Winner confirmed using winners list, Club Barona Card and valid, unexpired, government-issued photo ID, or a current Club Barona Card with imprinted photo to confirm winner (A player with identity information on file will also be acceptable to confirm a winner).

14. Winners do not need to be present at any drawing to win a prize.
15. No purchase necessary. Players do not redeem points for entries. Entries are based on the accumulation of Club Barona points on the player's Club Barona account during the promotion period.
